PROMO RULES

Discount means a discount of 50% from the initial price of the Ticket for the payment of a single ticket for the Kyiv Urban Electric Train in the city of Kyiv when paying with Visa cards at the validator or in the "Kyiv Digital" application.

Cards mean Visa payment cards issued by banks on the territory of Ukraine, including tokenized ones.

Ticket means one-time electronic ticket with a QR code that entitles you to travel on the Kyiv Urban Electric Train.

1. The procedure for participation in the Promotion by the Participants of the Promotion

- 1.4. The Cardholder, who has performed the actions specified in clauses 1.1.1-1.1.3 of the Rules, accepts the conditions of these Rules and becomes a Participant of the Promotion; from the moment of acceptance, these Rules are binding for the Participant of the Promotion. Such acceptance is unconditional.

2. Responsibilities of the parties

- 2.1. The Participant of the Promotion is responsible for the accuracy of the provided data and the right to use the Card, provided for by the current legislation of Ukraine.
