"Discount -30% on up to 6 tickets in public transport of the Lviv City Territorial Community" PROMOTION RULES (new edition dated 01.04.2024)

Promotion means a promotion offering a discount of -30% on the price of tickets (up to 6 tickets in the period from 01.04.2024 to 15.04.2024 and up to 6 tickets in the period from 16.04.2024 to 30.04.2024) for public transport of the Lviv City Territorial Community and/or a discount of UAH 27 when topping up a "LeoKart" transport card in the amount of UAH 100 (one hundred) in one payment through branded kiosks of the Interpress network in the period from 01.04.2024 to 15.04.2024 and again a discount of UAH 27 when topping up a "LeoKart" transport card in the amount of UAH 100 (one hundred) in one payment through branded kiosks of the Interpress network in the period from 16.04.2024 to 30.04.2024.

Public transport means all public transport of the Lviv City Territorial Community (trolleybuses, trams, buses, minibuses).

The Partner is Visa International Service Association, located at 900 Metro Center Blvd., Foster City, USA, CA 94404 - 2775.

Discount means a discount of 30% from the initial price of 1 (one) Public Transport Ticket in the Lviv City Territorial Community when paying through a validator that is built into the appropriate place in Public Transport (if available) by Visa bank card (physical card / device with support for Google pay / Apple Pay), up to 6 tickets in the period from 01.04.2024 to 15.04.2024 and up to 6 tickets in the period from 16.04.2024 to 30.04.2024, and/or a discount of UAH 27 when topping up a "LeoKart" transport card with a Visa bank card (physical card / device with support for Google pay / Apple Pay) in the amount from UAH 100 (one hundred) in one payment through branded kiosks of the Interpress network in the period from 01.04.2024 to 15.04.2024 and again a discount of UAH 27 when topping up a "LeoKart" transport card in the amount of UAH 100 (one hundred) in one payment through branded kiosks of the Interpress network in the period from 16.04.2024 to 30.04.2024.

Cards are Visa payment cards issued by banks on the territory of Ukraine, including tokenized ones.

Ticket means an electronic document that gives the right to travel (luggage transportation) in public transport of the Lviv City Territorial Community.

Organizer is LKP "LVIVAVTODOR", which is the automated fare payment system operator (identification code: 05523814, location: Ukraine, 79035, Lviv region, city of Lviv, 7 Pasyky Halytsky Str.).

Territory of the Promotion is Lviv city territorial community, Ukraine.

Participants of the Promotion are natural persons, holders of Cards, who have the right to participate in the Promotion in accordance with the provisions of these Rules.

1. The procedure for participation in the Promotion by the Participants of the Promotion and limitations of the Promotion

- **1.1.** For the purposes of participating in the Promotion, a person who wishes to participate in the Promotion and become a Participant of the Promotion must perform the following actions during the Promotion Period:
- 1.1.1. be the holder of a valid Card;

- 1.1.3. using the Card to purchase a Ticket for Public Transport through the validator built into the corresponding place in Public Transport (if available), and/or by topping up the "LeoKart" transport card in the amount of UAH 100 (one hundred) in one payment at branded "Interpress" kiosks.

Such purchase or top-up is carried out as follows:

- 1.1.3.1. by buying a Ticket by attaching the Card to the validator, which is built into the corresponding place in Public Transport (if available);
- 1.1.3.2. by topping up the "LeoKart" transport card with the Card in the amount of UAH 100 (one hundred) in one payment at branded "Interpress" kiosks.
- **1.2.** A discount when topping up a "LeoKart" transport card with a card in the amount of UAH 100 (hundred) in one payment is granted only once during the period from 01.04.2024 to 15.04.2024, and only once in the period from 16.04.2024 to 30.04.2024 when topping up a "LeoKart" transport card in the amount of UAH 100 (hundred) in a single payment at branded "Interpress" kiosks.
- **1.3.** A discount on the purchase of a Ticket by attaching the Card to the validator, which is built into the corresponding place in the Public Transport (if available), is granted for no more than 6 (six) tickets during the period from 01.04.2024 to 15.04.2024, and for no more than 6 (six) tickets in the period from 16.04.2024 to 30.04.2024 when paying with Visa cards.
- **1.4.** The Cardholder who performed the actions specified in clause 1.1. of the Rules (together with the subsections) accepts the conditions of these Rules and becomes a Participant of the Promotion; from the moment of acceptance, these Rules are binding for the Participant of the Promotion. Such acceptance is unconditional.

2. Obligations of the Parties

- 2.1. The Participant of the Promotion is responsible for the accuracy of the provided data and the right to use the Card, provided for by the current legislation of Ukraine.
- 2.2. The payment of taxes, fees and mandatory payments is carried out by the person on whom the corresponding obligation is imposed by the provisions of the current legislation of Ukraine.

- 2.3. All and any statements, proposals, complaints and claims regarding any reason for purchasing/using or attempting to purchase/using a Ticket (hereinafter referred to as "Complaint") must be submitted by the Participant of the Promotion directly to the Organizer.
- 2.4. Without any reservation stated above and not for the purpose of avoiding compliance with the provisions of the law, the Partner/Organizer shall not be liable for any damage caused to any property or person, as well as for the discrepancy of services with the expectations of the Participant of the Promotion or third parties.
- 2.5. The Partner is not responsible for the subject matter, quality, quantity, and timing of the provision of Public Transport services and is not a party to the agreement between the relevant parties regarding the receipt of Public Transport services.

3. Third-party services

The Participant of the Promotion, at their own discretion and under their own responsibility, accesses third-party websites and/or mobile applications, including the Organizer's websites, and independently assumes the associated risks.

4. Other provisions

- 4.1. The Organizer has the right to engage third parties to fulfil obligations under these Promotion Rules.
- 4.2. In the event of a situation involving an ambiguous interpretation of these Rules, any disputed issues and/or issues not regulated by the Rules, the Organizer reserves the right to resolve such issues. Such a decision of the Promotion Organizer is final and cannot be appealed.
